

Mandatory training, **Poole site update** - March 2021

Welcome to this information leaflet about the changes with mandatory training and induction now we are UHD.

BEAT VLE

The BEAT Virtual Learning Environment (VLE), also known as the 'Green Brain', launched at Poole hospital on 4 January 2021.



This system allows all staff to access their training record and complete eLearning for mandatory core skills. The VLE has a traffic light system so you can monitor when you need to complete your training, and your

Brain will turn green when you are in date.

It replaces training on eLearning for Healthcare, which we no longer accept certificates for from January 2021. Any certificates for training completed prior to this date will be accepted – email certificates to <u>mandatory.training@uhd.nhs.uk</u>

Most of the mandatory subjects are aligned through this eLearning system and we are working to sort out anomalies that may exist, e.g. people doing a higher or lower level of training depending on their job role or having courses on their 'brain' that are not applicable, e.g. staff with Dementia Tier 2

If this subject remains red on your 'brain' this is because we have not yet made the changes in the system please email <u>e.Learning@uhd.nhs.uk</u> who will provide an email as evidence to say why this is the case.

Some subjects that appear on the BEAT VLE will require you to undertake face-toface training. When you click on these subjects it will tell you how to book a place on a class. <u>Click here</u> for more information.

Covid-19 Safer Working Toolkit

We no longer ask managers to update the Covid-19 Safer Working Toolkit in ESR as it is now available for all staff to complete via the BEAT VLE.

Local Induction

We also no longer ask managers to update the <u>Local Induction Workbook</u>. The checklist for local induction is now included within the BEAT VLE along with instructions on how to update it.

Fit Testing

We are looking at how we keep up to date records of FIT testing across the Trust in one place. We will be recording this on ESR. If you FIT tested staff at Poole or have done in the last in the last 12 months, please forward details of the staff name, date of test and their employee (assignment) number to <u>mandatory.training@uhd.nhs.uk</u>

Fit testing will have a two-yearly competency attached to it which the education department, across both sites, will record the details in the member of staff's records (as we do with all training records). Work is in progress for this to be on the BEAT VLE which will then remind staff when to update.

Mandatory Training

Face-to-face training has restarted, but still with limited numbers due to social distancing. Please book through ESR self service if based at RBCH or via the <u>intranet</u> at Poole. Some of the face-to-face training includes dementia tier 2, conflict resolution, breakaway, etc. When staff see their training on the BEAT VLE they will be able to see if training is face-to-face by clicking on the topic.

Face to Face Mandatory training classes include:

- Blood transfusion
- Breakaway (previously conflict resolution training level 2)
- Clinical skills
- Conflict resolution
- Dementia tier 2
- Moving and handling level 2
- Resuscitation level 2

Induction

As of October 2020 we have aligned our **trust induction day 1** which is our opportunity to welcome new starters to the Trust. This runs across both sites and in time this will run on alternate days of the month but we are not there yet. We have four trust inductions per month – two at the beginning of the month and two midmonth and we look to amalgamate the mid-month one if the numbers of attendees are low.

- Health Care Support Workers (HCSW) induction comes from the main induction and from April 2021 these will operate on alternate times of the month. This induction at Poole will be at the beginning of the month and the Bournemouth induction will take place in the middle of the month. We would recommend that new staff complete their induction at their home site but we can be flexible as the inductions are aligned.
- NOT all our mandatory subjects are fully aligned, this is work in progress with the subject matter experts but we will inform staff what they need to do differently if they attend an Induction day at the other site to their main workplace. E.g. Bloods face to face talk and some subjects not yet aligned on the BEAT VLE have to be delivered differently.
- Trust Induction day one is for ALL staff to attend, even if they have other inductions to go to after, that are role specific e.g. HCSW/medical (for doctors in training).

• Due to on-going Covid restrictions we are still asking some staff to access their induction from home but this will change as we can make use of more space in the lecture theatre following Government guidance on social distancing.
